2024 GLEN ECHO PARK PROJECTS

In addition to supporting our day-to-day operations, a portion of your sponsorship can support one of the following Park priorities:



PRESERVATION

The historic exterior of the Crystal Pool could be transformed into many things for the community to use. The first step is a study to assess the area for structural repairs. **Remaining cost to raise this year: \$59,000**

GROUNDS & GARDENS

In addition to maintaining 9 acres of parkland, the Partnership enhances the visual appeal of the grounds' with projects such as The Magic Garden at the park's back entrance. Support our plan to add native plantings throughout the Park and develop a tree replanting program.

Estimated cost: \$18,000

CHILDREN'S PLAY

The park's playground is a gathering spot for children from around the region, and is in need of an overhaul. Support the playground design process, which is the first step to present our plans for National Park Service approval.

Total design cost: \$10,000



ARTS & CULTURAL EVENTS

Each year, the park hosts hundreds of free public events funded by grants and donations. These include large-scale events such as the Labor Day Art Show and continued exhibitions in the galleries.

Next up: Free Summer Concerts- production cost: \$12,000

HISTORY & CIVIL RIGHTS

Emmy award-winning documentary filmmaker Ilana Trachtman is nearing completion of her film, "Ain't No Back to a Merry-Go-Round" which tells the story of civil rights protests at the Glen Echo amusement park in 1960. We will organize a public screening when the film is complete.

Estimated cost: \$7,500

YOUTH OUTREACH

With the Park's Youth Outreach and Scholarship Fund, we provide scholarships and transportation assistance for kids in need to attend Park camps, classes, special projects or performances at the Park. **Cost of sending one child to camp for one week: \$525**
